BUILDING RESPONSE TEAM (BRT) ROLES



"The primary role of the BRT is to provide for the safety and security of the campus."

BUILDING RESPONSE TEAM (BRT) ROLES

During a crisis situation (eg. environmental crisis, physical safety threats, emotional well-being threats, and bereavement crisis) the coordination of physical safety and mental health support systems must be in place



O2 DRILLTYPES



Lockdowns

Soft lockdown: No Imminent Danger

Administrative teams, Building Response Teams, and School Safety Agents will meet at the designated command post for further direction.

Hard Lockdown: Imminent Danger

No NYCDOE should clear the school in a hard lockdown. All individuals, including School Safety Agents will take appropriate lockdown action and await the arrival of first responders.

Lock & Hold!



Hold will be initiated to manage an incident or building condition which does not place the school community in danger, or when directed by first responders.

Lock & Hold!

Hold does not replace a soft or hard lockdown.

When the Hold action is initiated, staff, students, and visitors must remain in place when the Hold announcement is made. Individuals will conduct business as usual until the "All Clear" is announced.

The BRT and School Safety Agents will address the issue and conduct a building sweep. Anyone found in restrooms, hallways, stairwells, or the lobby will be taken to a designated area until the "All Clear" announcement is made.



Annual School Safety Plan Initiative

Safety Plan is created via collaboration between PS 939, MS
 936, and the New York City Department of Education.

• All NYCDOE school must partner with the New York City Police Department (NYPD) to ensure safety. NYPD must approve plan



Key Elements of the Safety Plan

- Detailed information on building and school programs that occur during the day.
- Special protocols for students and staff with special needs, ensuring their safety during evacuations and medical emergencies.

 Emergency response information, including procedures and roles during critical situations.

Ensuring Transparency and Accessibility

- Assurance that parents have full access to the safety plan information.
- Moving forward, the policy of providing parents with the school safety plan at the beginning of each school year.
- Encouraging parental feedback and involvement in enhancing safety measures.
